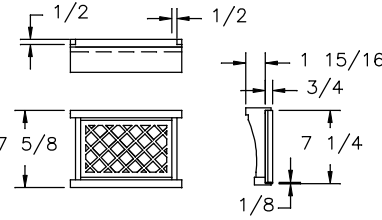
TYPICAL POCKET DOOR
JAMB CONFIGURATION



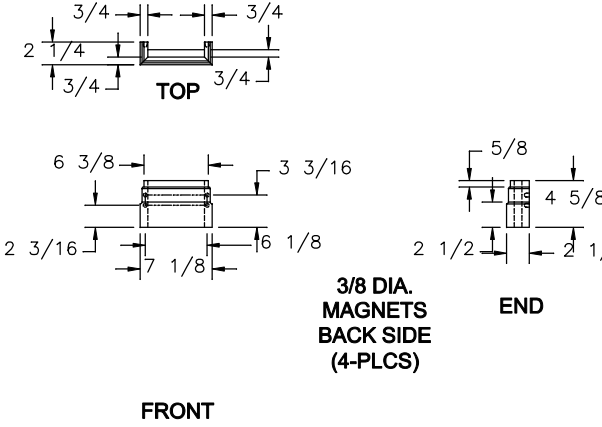
TYPICAL CENTER BLOCK
