DESCRIPTION

Newmar Corporation has decided that a defect relating to motor vehicle safety exists in specific 2012 and 2013 Essex and 2012 King Aire motorhomes. This is in response to notification from Spartan Motors, Inc. Attached is a list of specific unit numbers affected.

Issue: A defect relating to the modulator valves making contact with the IFS relay rod may exist in certain vehicles equipped with an IFS2000 model front suspension. When the steering wheel is turned, the relay rod may interfere with the ABS modulator valve if the valve is in an incorrect orientation and the steering relay rod is in the full forward position during full right or left turns.

Condition: If enough contact is made with the ABS modulator valve, the valve may fracture. This may result in air not being applied to the affected side during a braking event. This may reduce stopping distance of the vehicle or cause the vehicle to pull to one side, which could result in a vehicle crash.

RECOMMENDED ACTION

Correction: An Authorized Service facility will inspect the modulator valve and, if needed, add a spacer behind the ABS modulator valve. Spartan Motors, Inc. has provided the attached work instructions.

If you are contacted by the current owner who has not received a recall letter, you should verify that they have an affected chassis by calling Spartan 1-800-543-4277 (opt. 0) for verification.

This notice is sent to you as a Newmar Dealer in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Newmar Corporation has decided that a defect which relates to motor vehicle safety exists in specific Newmar recreational vehicles.

The National Traffic and Motor Vehicle Safety Act requires that each vehicle which is subject to a recall campaign of this type must be satisfactorily repaired within a reasonable time after the owner has tendered it for repair. A failure to adequately repair within 60 days after tender of a vehicle is prima facie evidence of failure to repair within a reasonable time. If the condition is not properly repaired within a reasonable time, the owners may be entitled to an identical or reasonably equivalent vehicle at no charge or to a refund of the purchase price less a reasonable allowance for depreciation.

To avoid providing these problematic solutions, every effort must be made to promptly schedule an appointment with each owner and to repair their vehicle as soon as possible. Vehicle owners are being notified of this recall. If the condition is not remedied within a reasonable time, they are instructed on how to contact the National Highway Traffic Safety Administration.

REASON FOR THIS RECALL

Newmar Corporation has decided that a defect which relates to motor vehicle safety exists in specific motor homes. This is in response to notification from Spartan Motors, Inc.

On certain motorhomes, equipped with IFS2000 model front suspension, the shaft of the ball joint on the steering relay rod may contact the ABS valve, if the valve is an incorrect orientation and the steering relay rod is in the full forward position during full right or left turns. If enough contact with the ABS modulator valve is made, the valve may fracture which could result in air not being applied to the affected wheel. This could occur without warning. A fractured ABS modulator valve could allow air to not be applied to the affected side during a braking event. This may reduce stopping distance of the vehicle or cause the vehicle to pull to one side which could result in a vehicle crash. Correction: An Authorized Service facility will inspect the modulator valve and if needed add a spacer behind the ABS modulator valve.

Motorhomes included in this recall include:

2012-2013 model year Essex Class A motorhomes.

2012 model year King Aire Class A motorhomes.

These motorhomes were built between 3/22/2011 and 1/08/2013.

These motor homes require immediate service. Continued use poses a potential safety hazard.

DEALER CAMPAIGN RESPONSIBILITY

Dealers are to provide to all customers/owner vehicles the service of completing this campaign at no charge to the customer/owner regardless of vehicle age, vehicle mileage, or ownership at the time of repair.

REPAIR PROCEDURE

Spartan Motors, Inc. will provide the work instructions. The Authorized Service facility will inspect the modulator valve and if needed add a spacer behind the ABS modulator valve.

This notice is sent to you as a Newmar Dealer in accordance with the requirements of the Canada Motor Vehicle Safety Act. Newmar Corporation has decided that a defect which relates to motor vehicle safety exists in specific Newmar recreational vehicles.

Each vehicle which is subject to a recall campaign of this type must be satisfactorily repaired within a reasonable time after the owner has tendered it for repair. A failure to adequately repair within 60 days after tender of a vehicle is prima facie evidence of failure to repair within a reasonable time. If the condition is not properly repaired within a reasonable time, the owners may be entitled to an identical or reasonably equivalent vehicle at no charge or to a refund of the purchase price less a reasonable allowance for depreciation.

To avoid providing these problematic solutions, every effort must be made to promptly schedule an appointment with each owner and to repair their vehicle as soon as possible. Vehicle owners are being notified of this recall. If the condition is not remedied within a reasonable time, they are instructed to contact Transport Canada.

REASON FOR THIS RECALL

In response to notification from Spartan Motors, Newmar Corporation has determined that a defect which relates to motor vehicle safety exists in specific motor homes built on Spartan chassis.

On certain motorhomes equipped with IFS2000 model front suspensions, the ABS valve may have been incorrectly oriented at time of installation. As a result, the shaft of the ball joint on the steering relay rod may contact the valve during full right or left turns. If enough contact is made, the valve may fracture without warning, which could result in service brake air pressure not being applied to the affected wheel. This may increase stopping distances or cause the vehicle to pull to one side which could result in a vehicle crash. Correction: An Authorized Service facility will inspect the modulator valve and if needed add a spacer behind the ABS modulator valve.

These motor homes require immediate service. Continued use poses a potential safety hazard.

This recall applies to certain Newmar motorhomes built between 4/15/2011 and 10/22/2012.

1. Locate left and right ABS modulator valves on front IFS suspension. Refer to FIG. 2-1.

2. Remove (2) 5/16 in. bolts, (4) washers, and (2) nuts that mount ABS modulator valve to suspension. Retain washers and nuts for reuse. Refer to FIG. 3-1.

NOTE: Do not remove airline or brake drop hose from valve.

- 3. Install spacers between ABS modulator valve & mounting plate. Refer to FIG. 3-1.
- 4. Install new bolts, retained washers, and retained nuts. Torque nut side to 15 lbs. ft.
- 5. Repeat steps 2 through 4 for opposite side.


