<u>Issue</u>: On certain motorhomes, the power steering pump may have an undersized bore in the spool housing. This may cause the spool to stick resulting in reduced power steering fluid flow, which may result in an intermittent loss of power steering. This could happen without warning. An intermittent loss of power steering could increase the risk of a crash and/or property damage.

<u>Correction</u>: The power steering pump will be inspected and replaced as needed by an authorized Spartan service center.

#### **REASON FOR THIS RECALL**

In response to notification from Spartan Motors USA, Newmar Corporation has decided that a defect which relates to motor vehicle safety exists in specific motor homes built on Spartan chassis.

On certain motorhomes, a defect in the power steering pump could result in an intermittent loss of power steering assist without warning. This would unexpectedly increase the steering effort force necessary to steer the vehicle, which could increase the risk of a crash causing injury and/or damage to property. Correction: Dealers will replace the power steering pump.

These motor homes require immediate service. Continued use poses a potential safety hazard.
