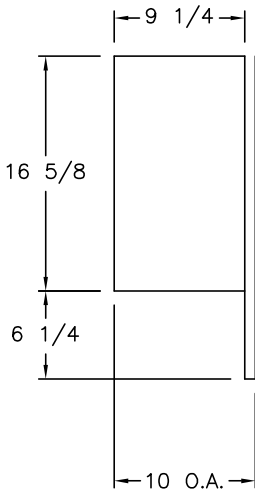

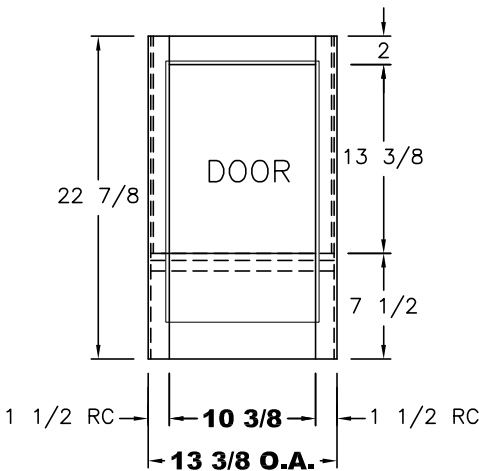


1/2" SOLID SURFACE EDGE

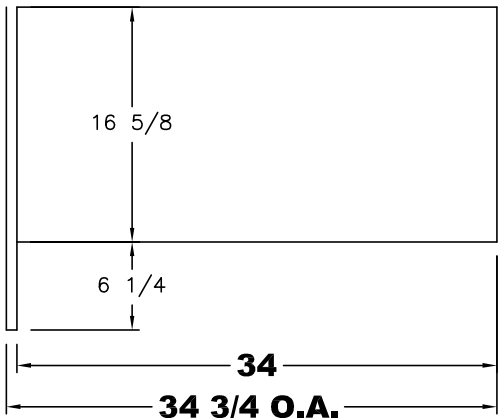
RIGHT SIDE VIEW

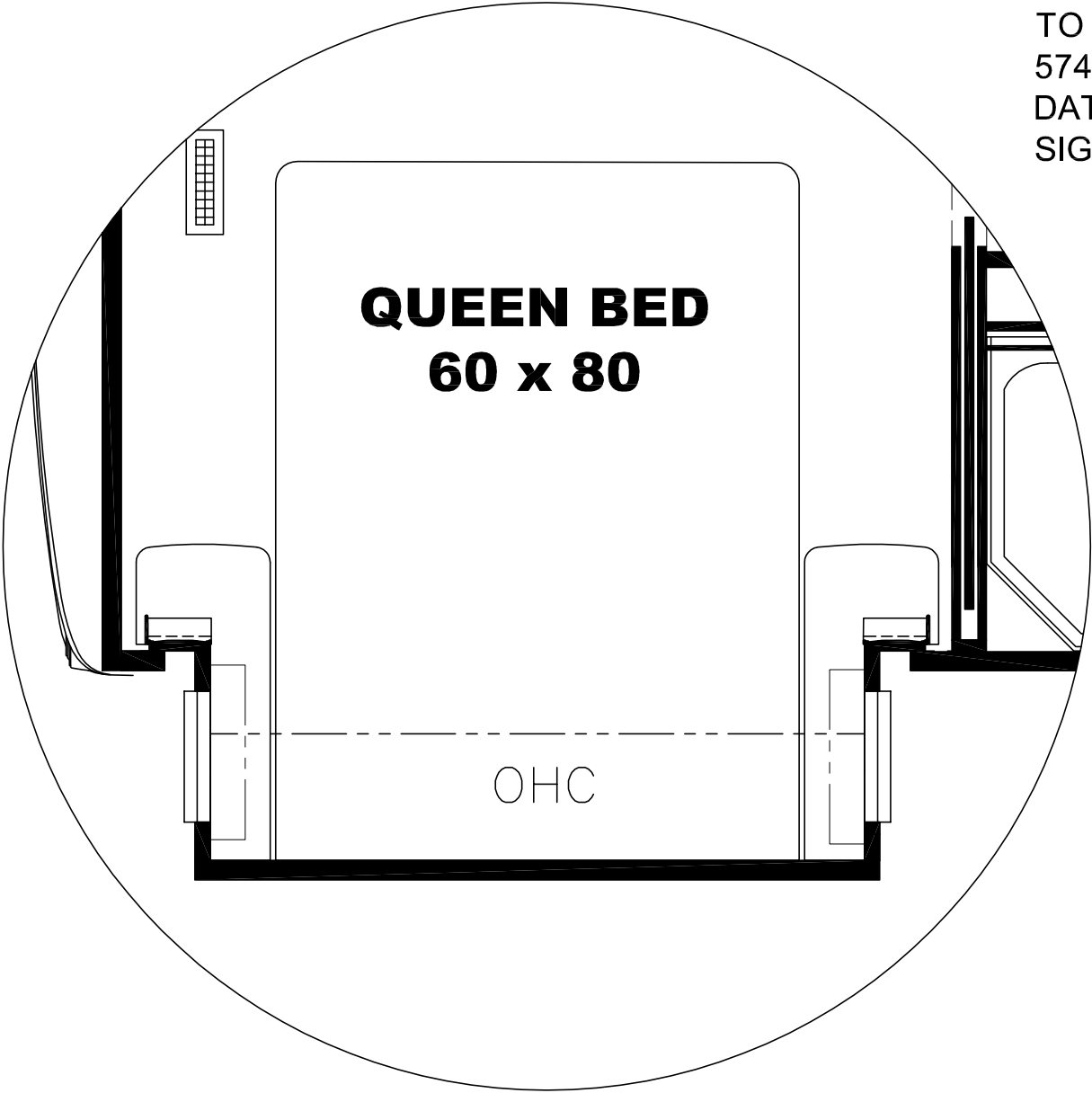
