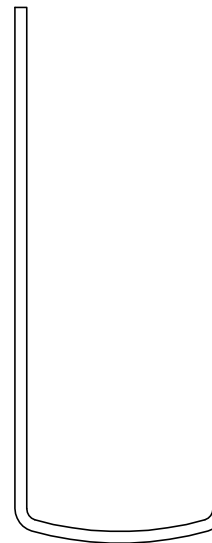

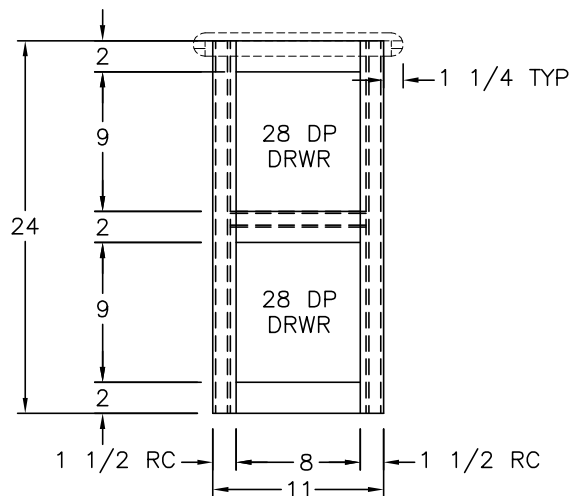

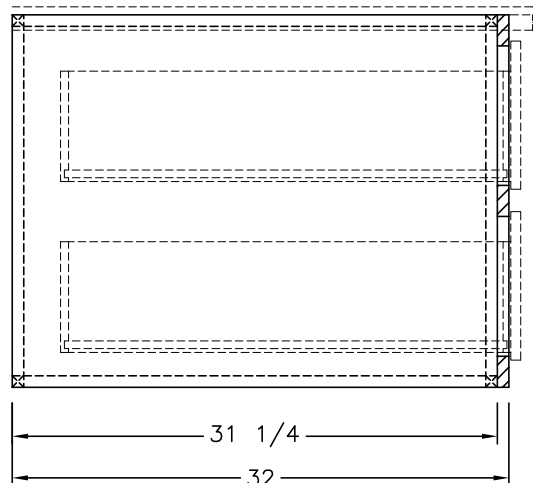


EDGE TRIM
