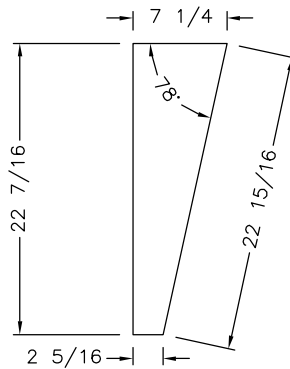

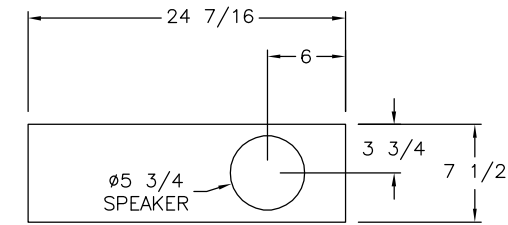
SIDE PANEL A
