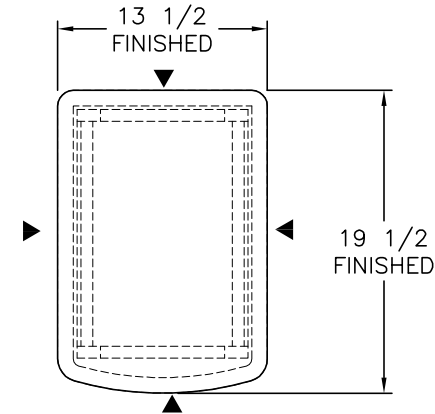

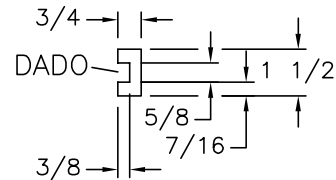

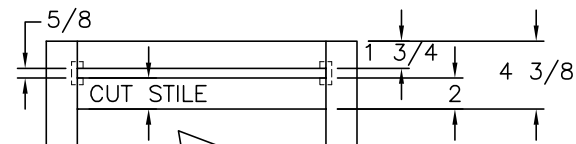

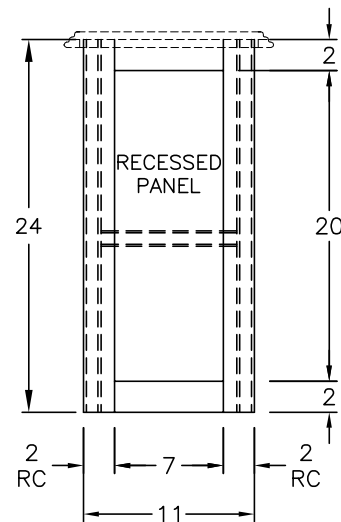

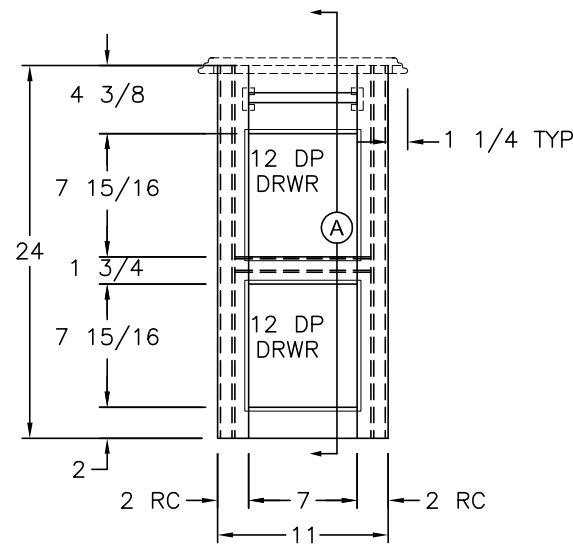

CABINET BASE FRONT VIEW



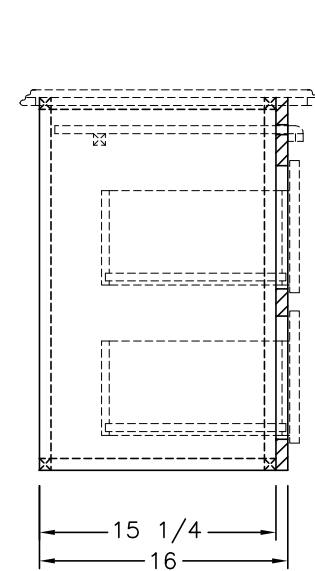

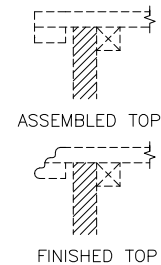
