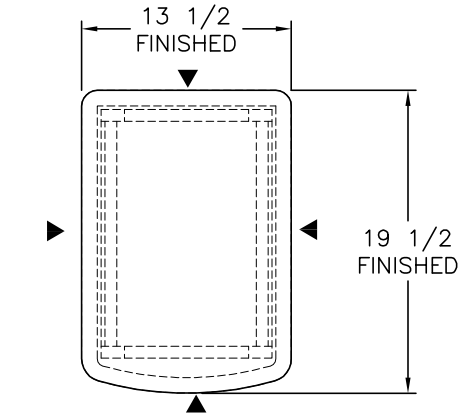

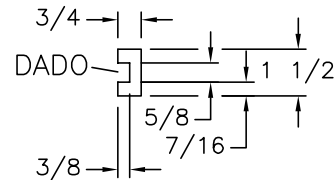
BOTTOM VIEW

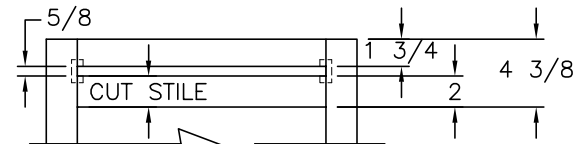

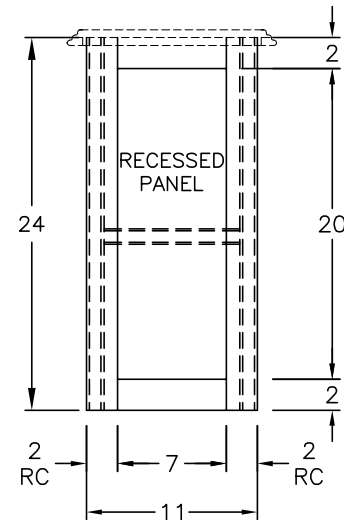

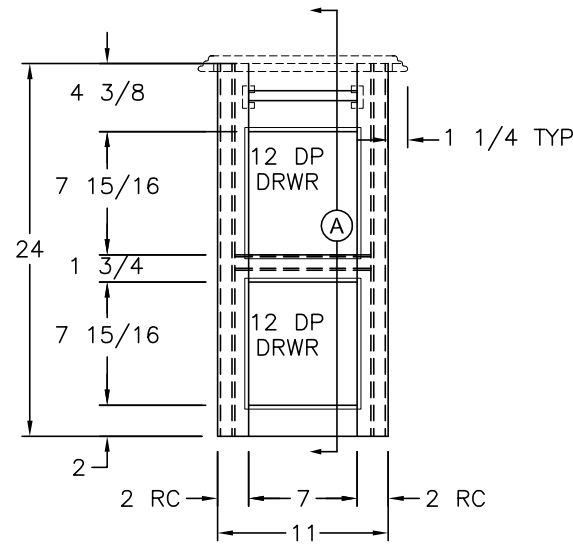
HARDWOOD

CABINET BASE FRONT VIEW

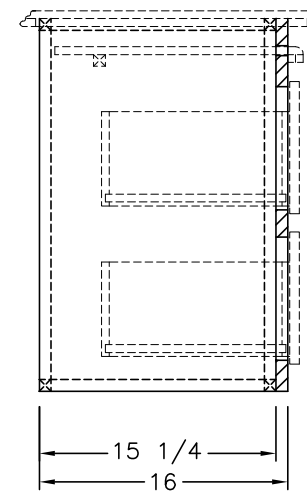

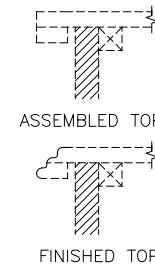
