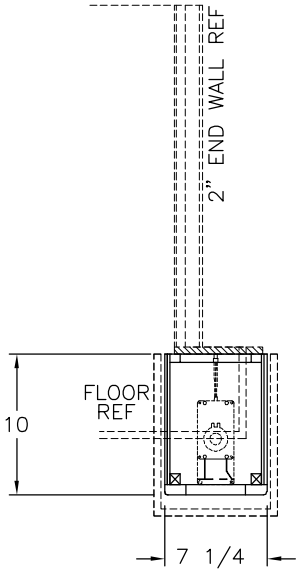
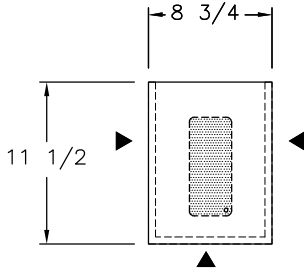

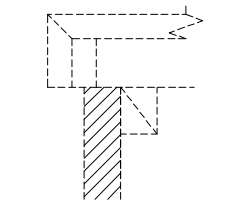


REAR CHEST

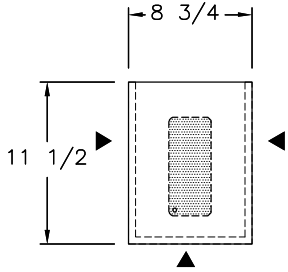

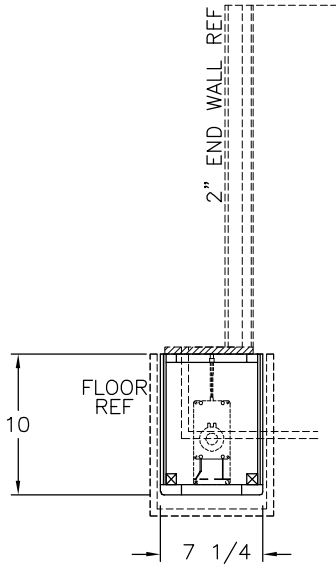

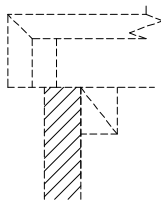


CHEST TOP

TOP VIEW

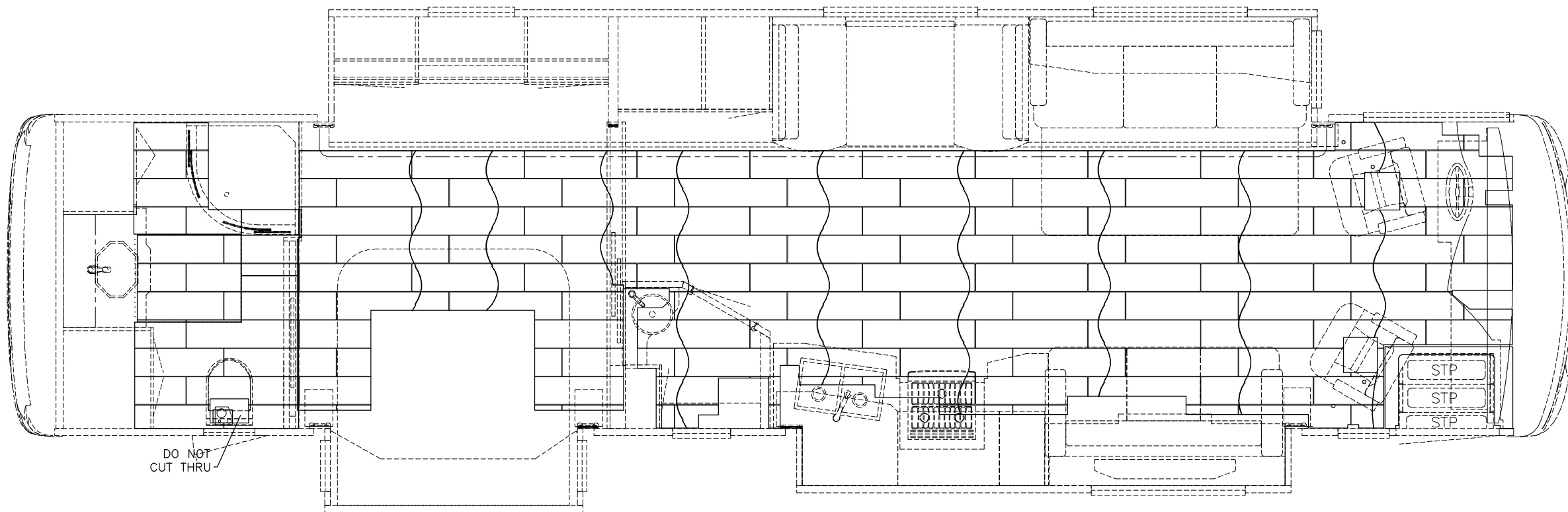
