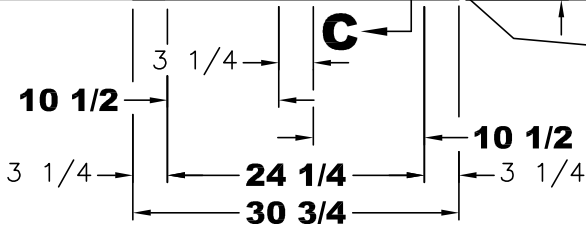
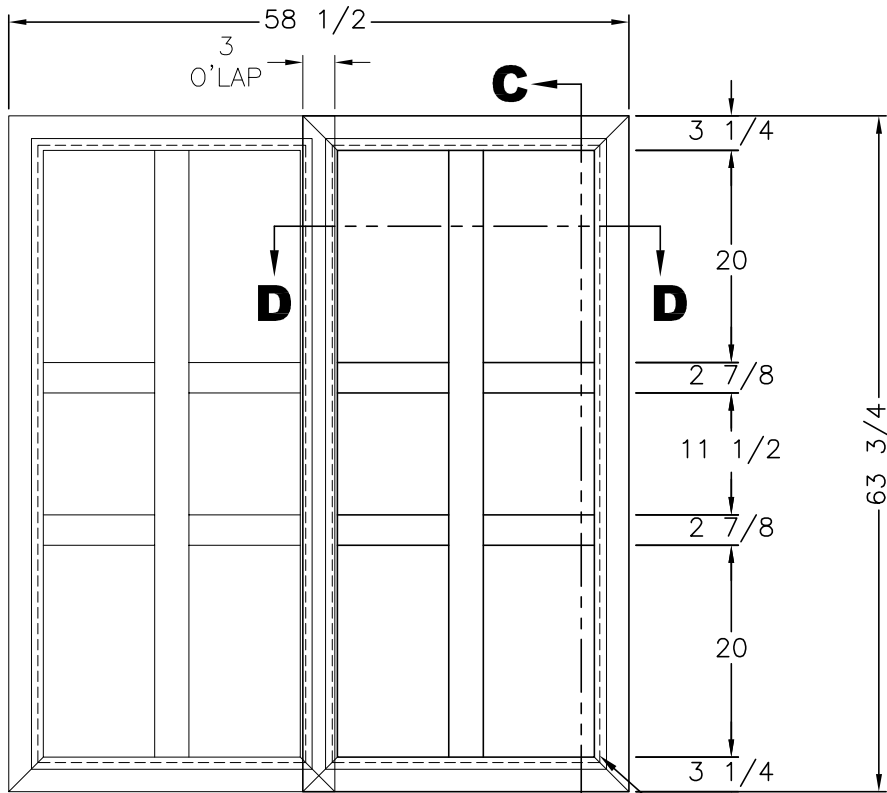


FRONT VIEW (FRAME)
