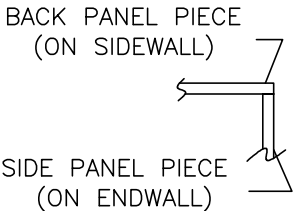


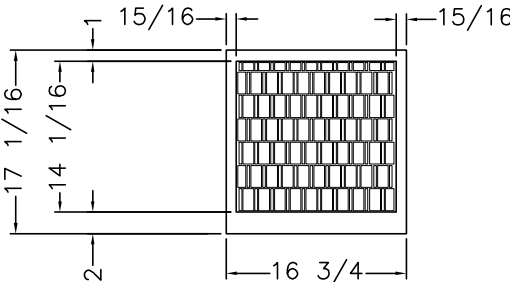
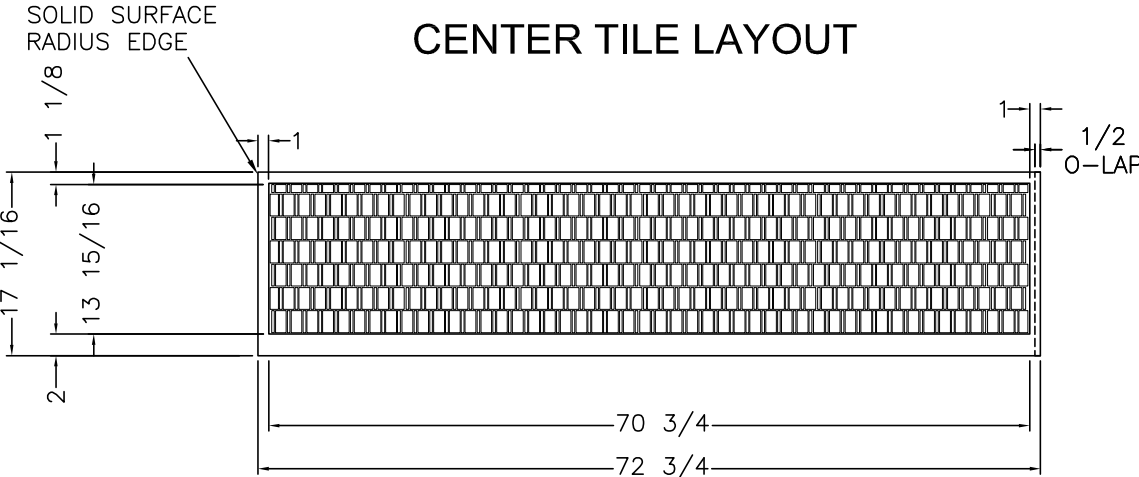

SIDE PANEL PIECE (ON WALL.)

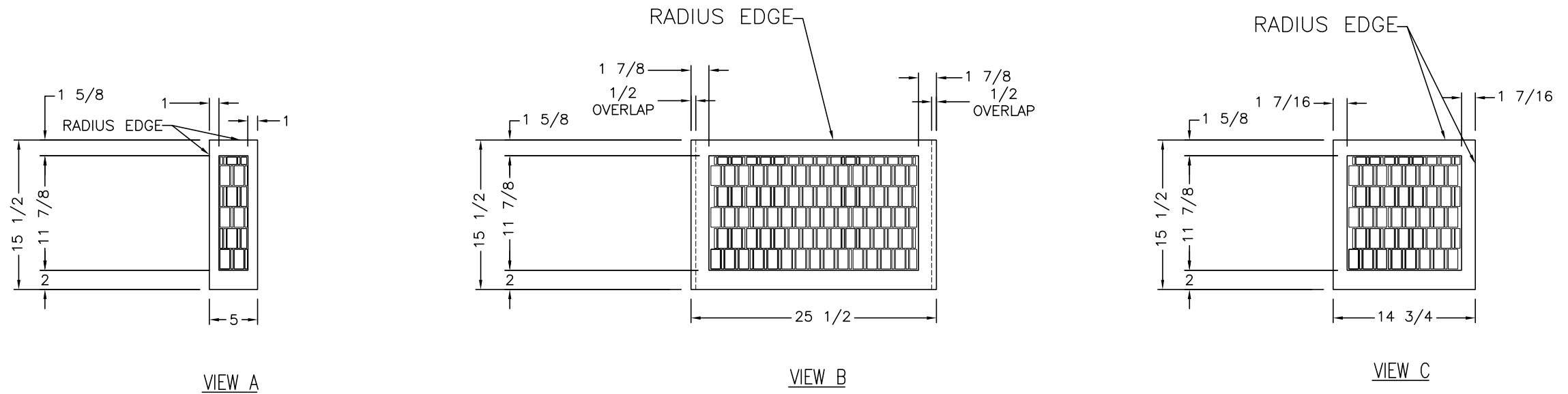

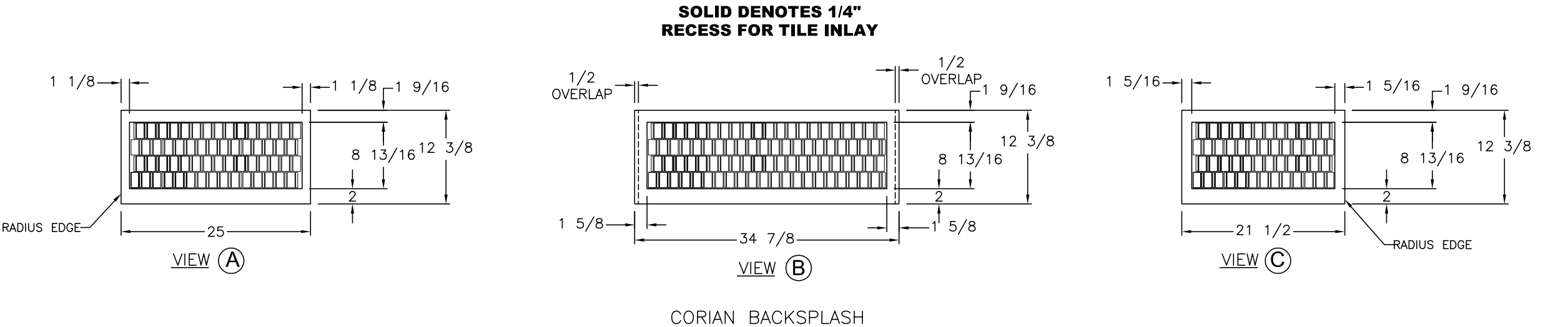

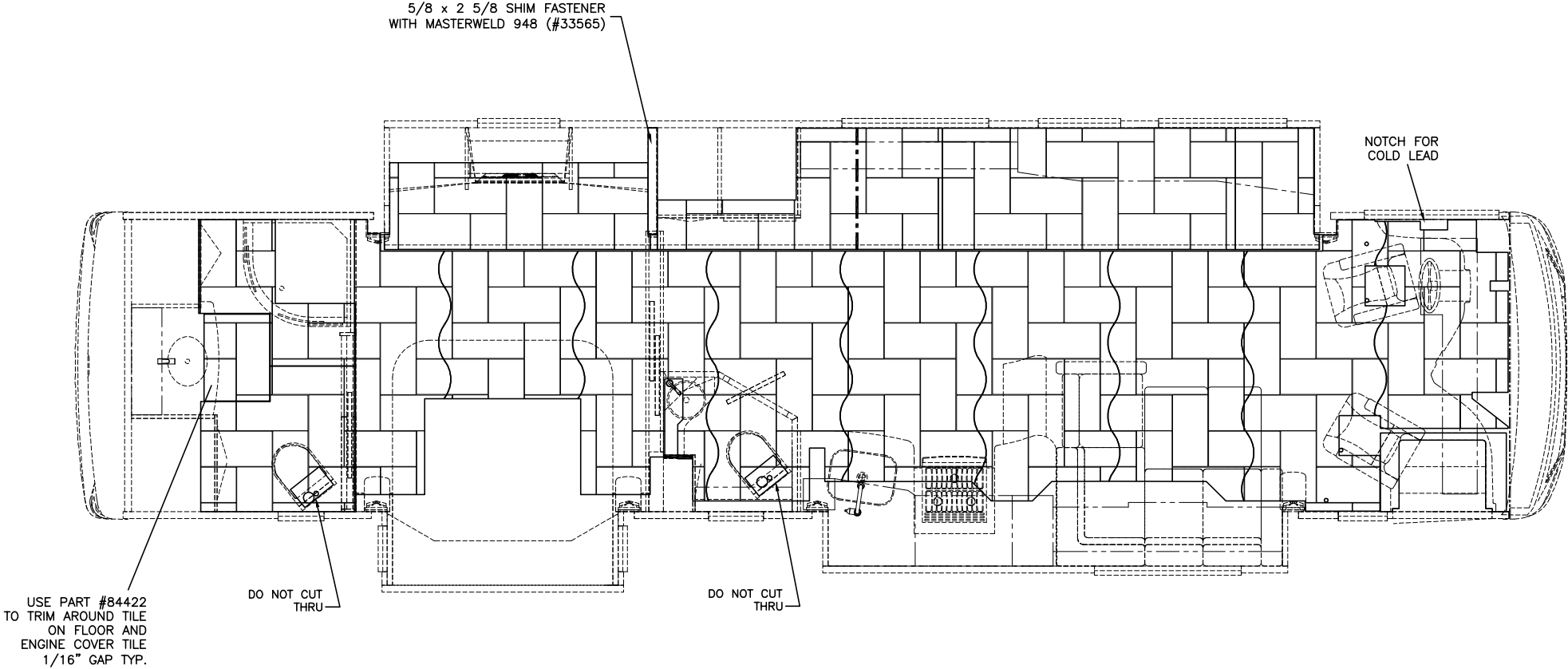
