CENTER TILE LAYOUT

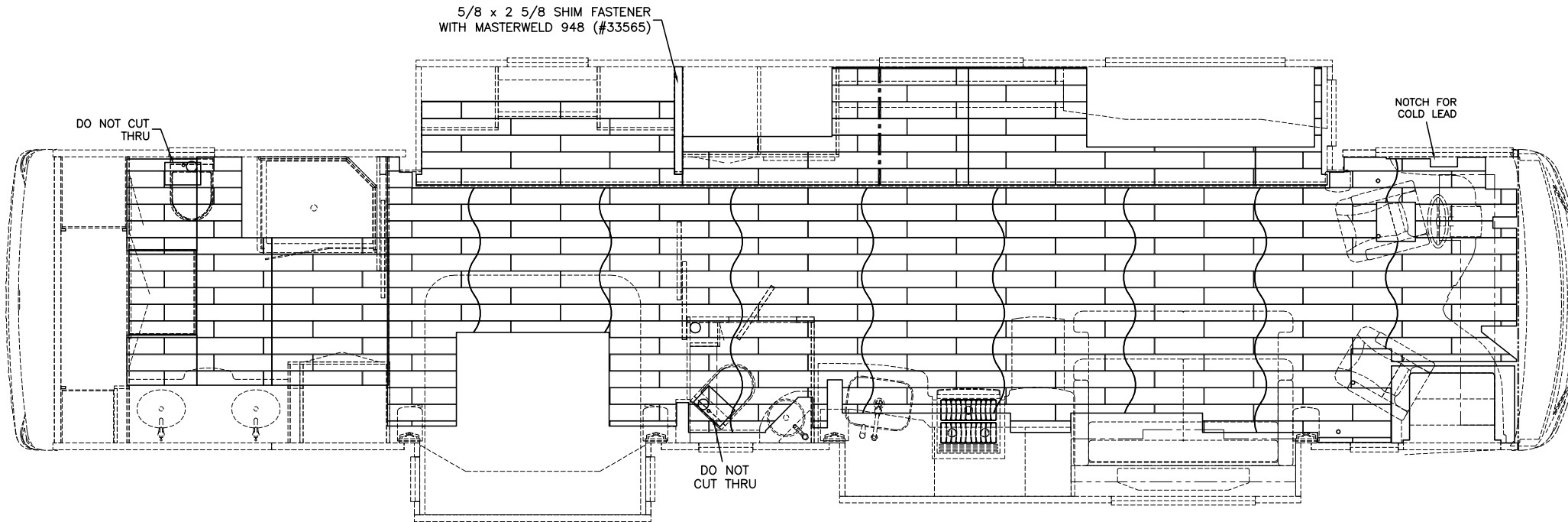
