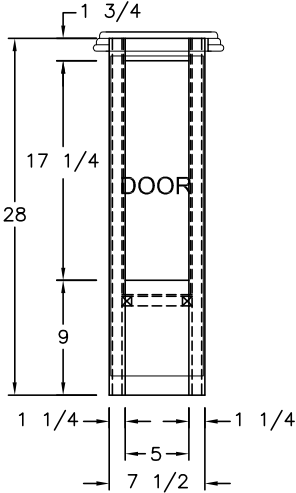
TOP VIEW



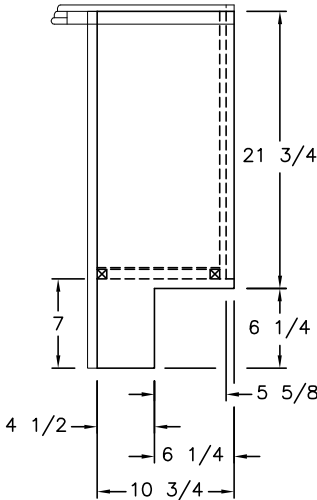
DOOR OVERHANGS

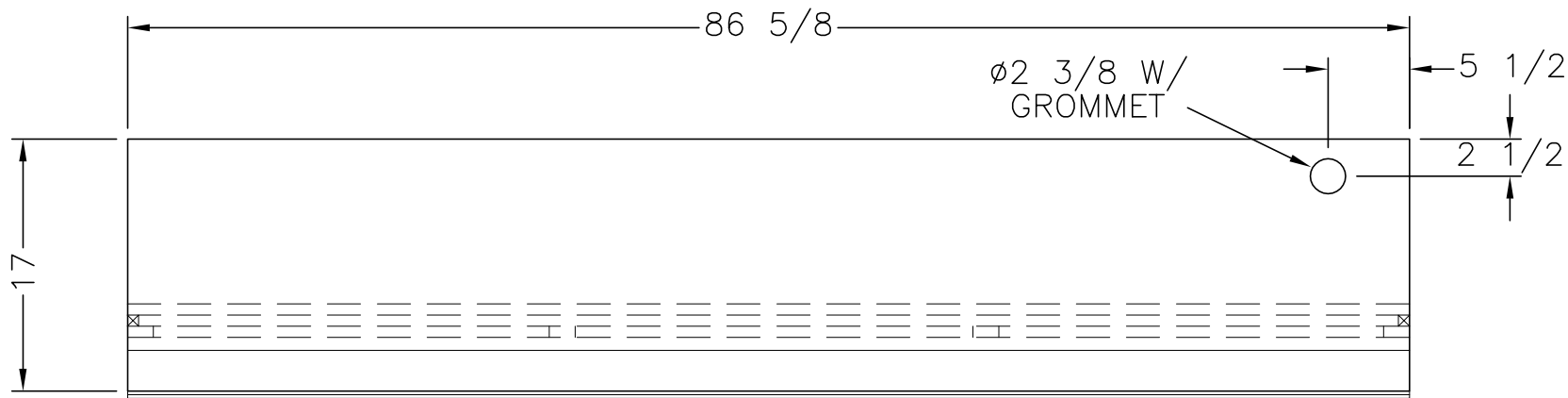
