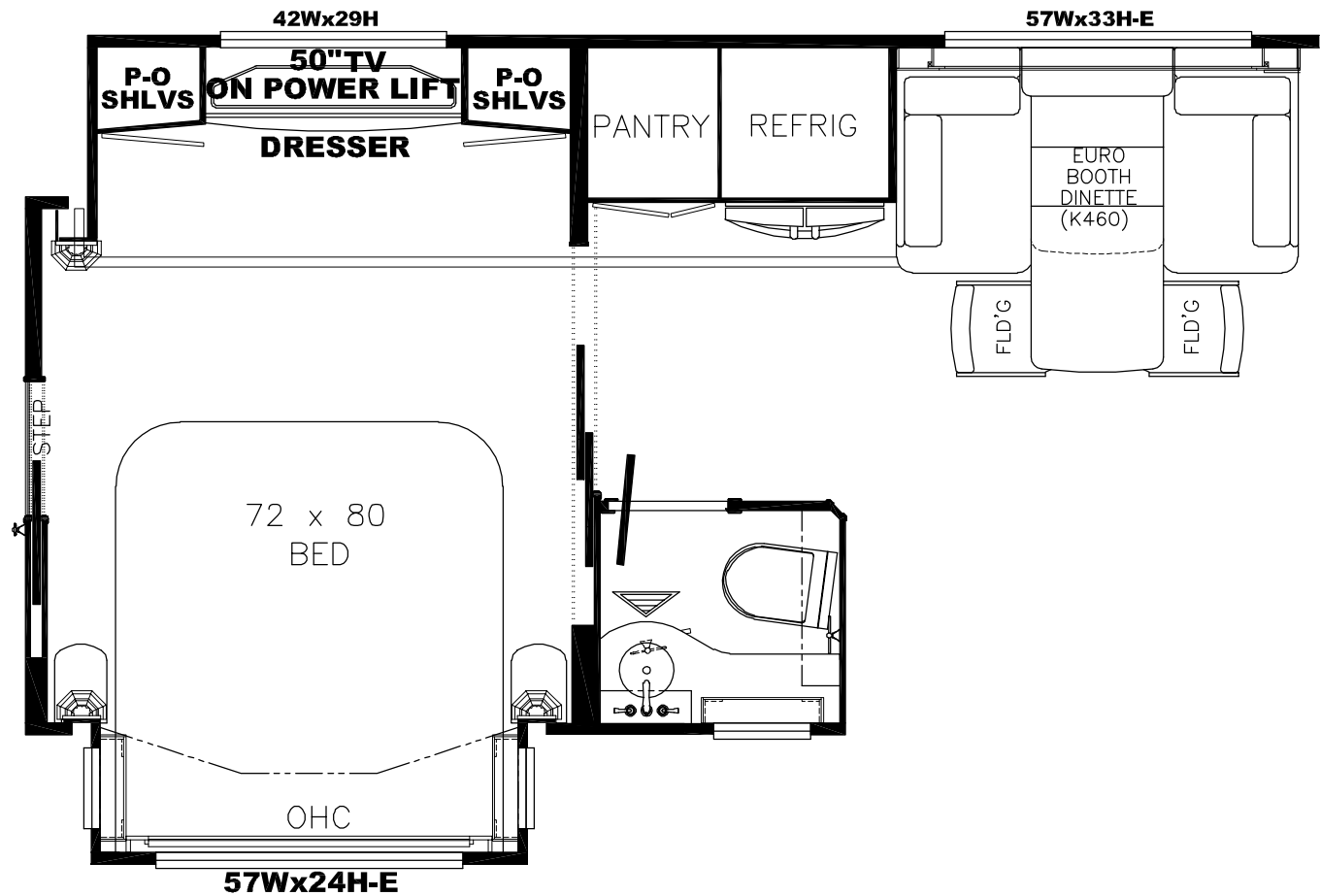


ISOMETRIC
