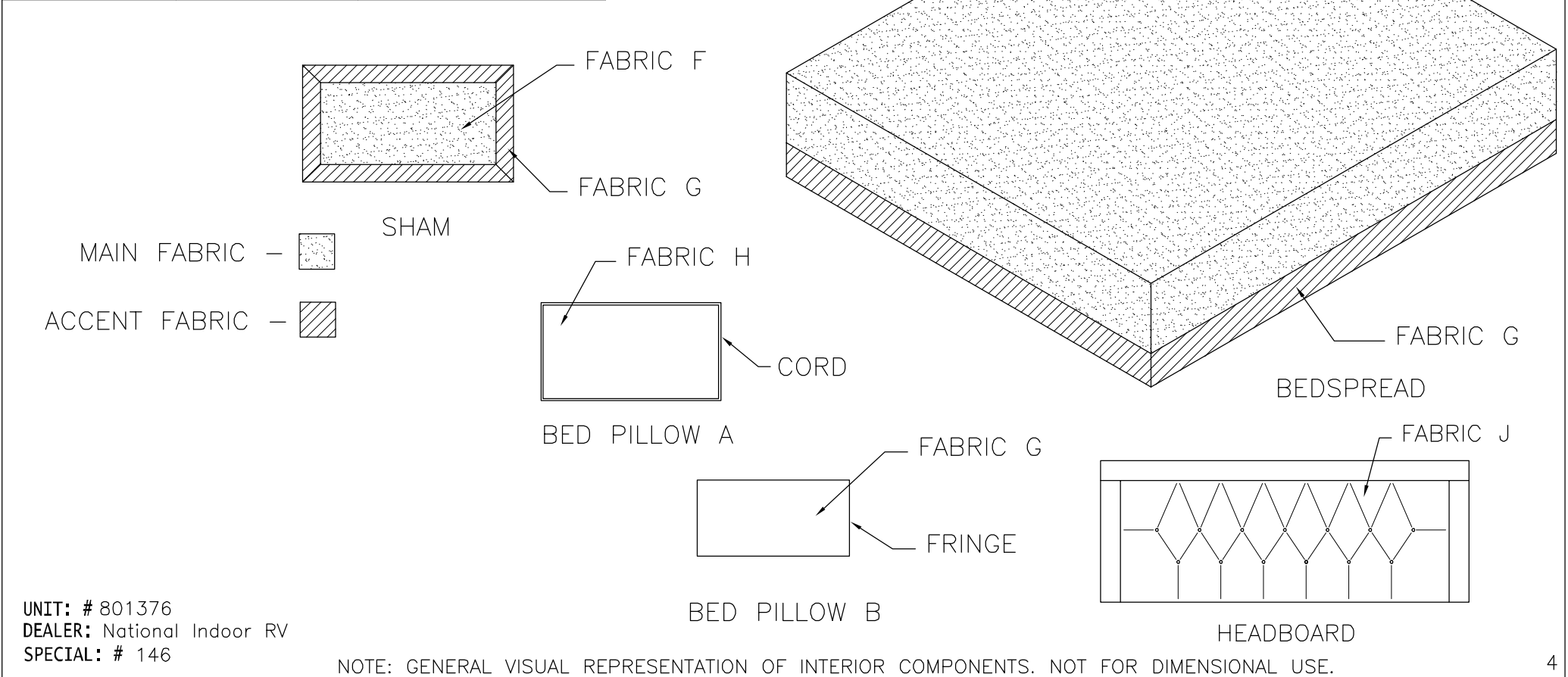


ISOMETRIC
