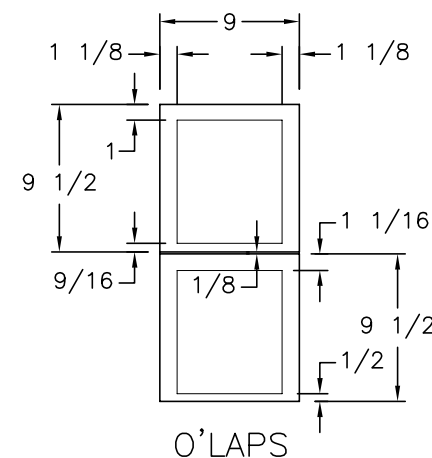
FRONT VIEW

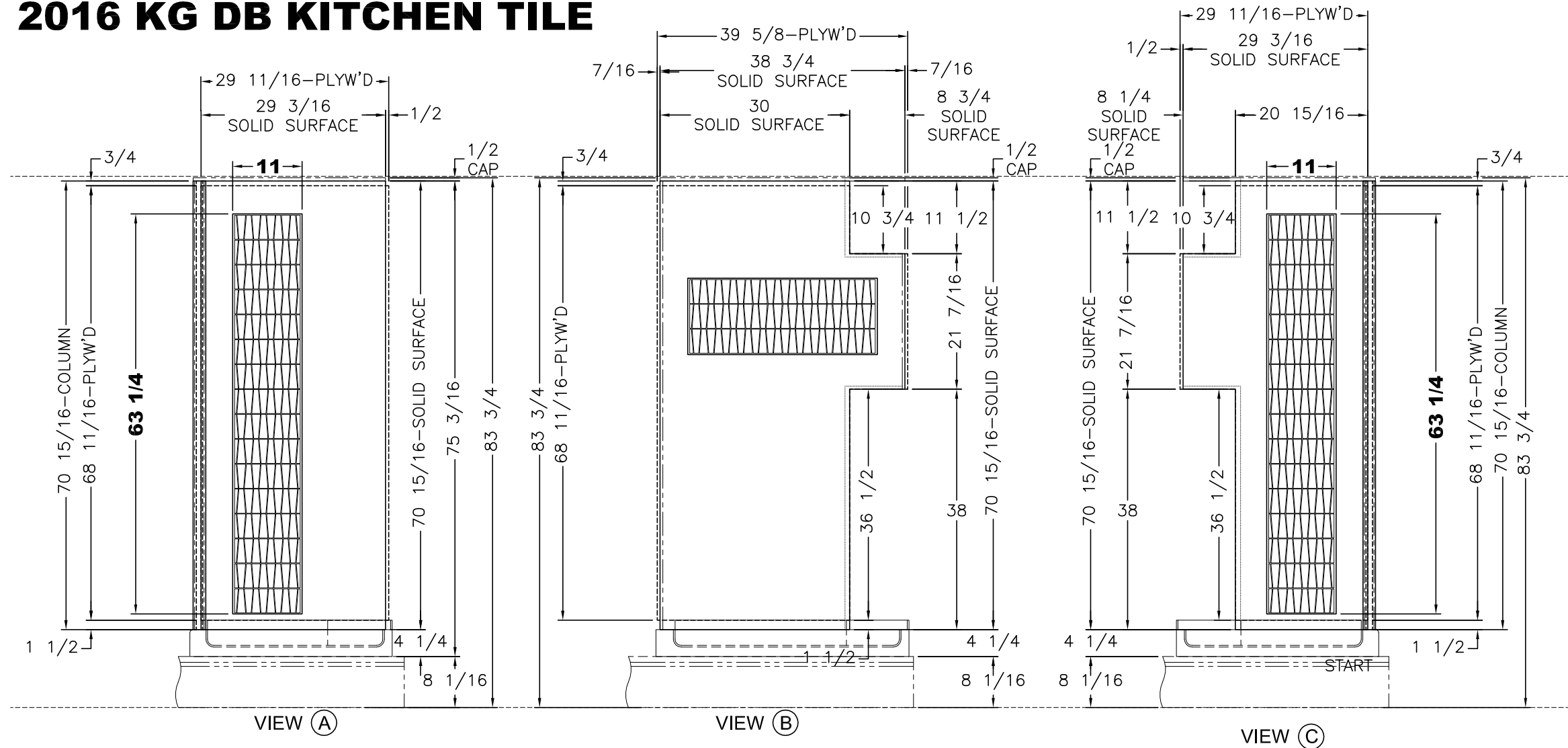


TOP/O'LAPS/SPLASHES/ELEVATION
