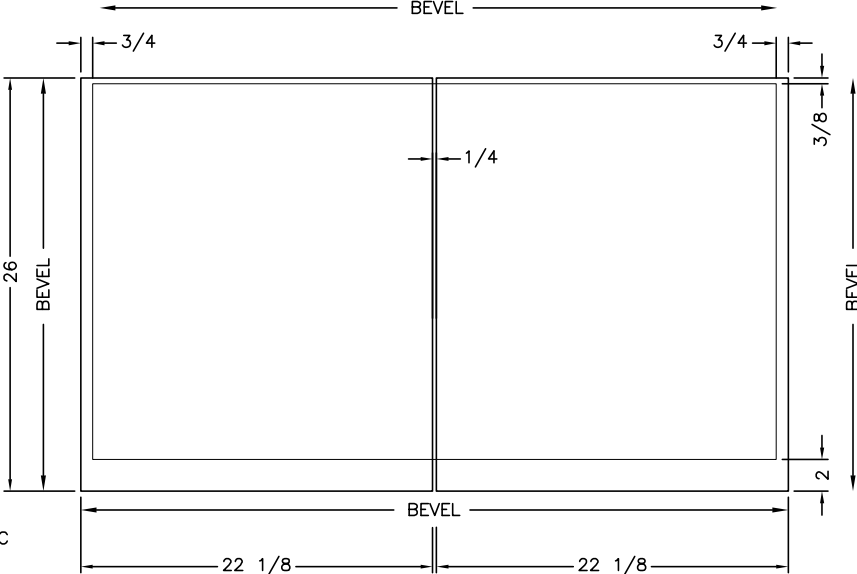

SPLIT-MIRROR DOOR DETAIL



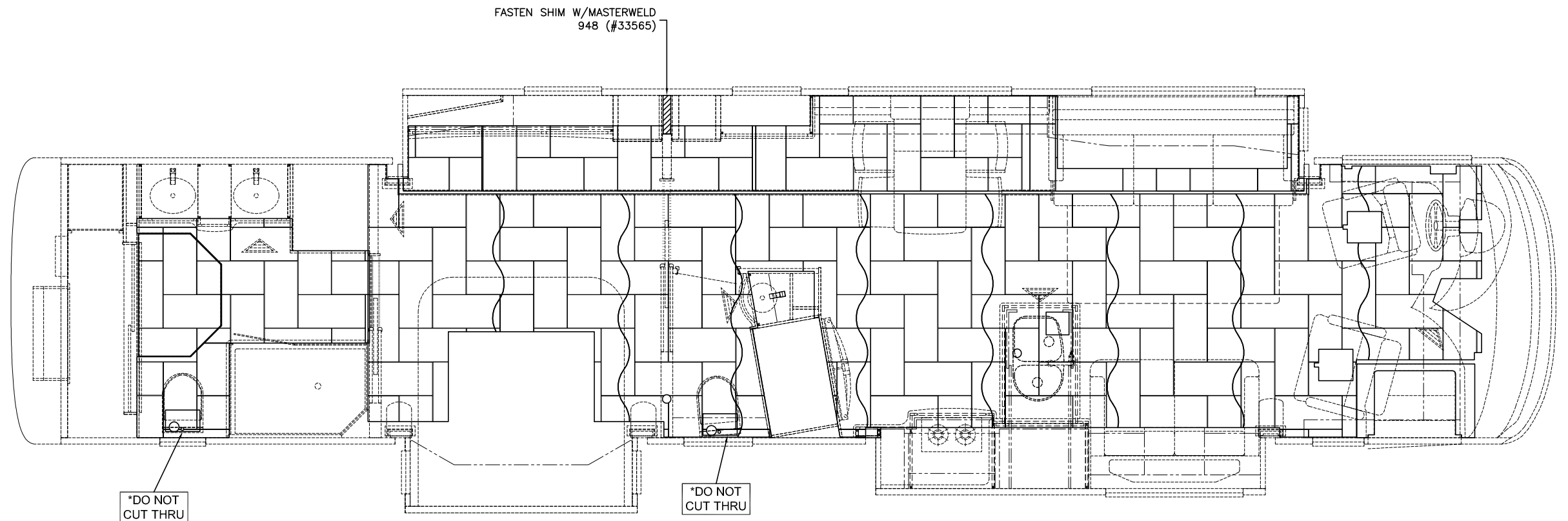
DOOR FRAME

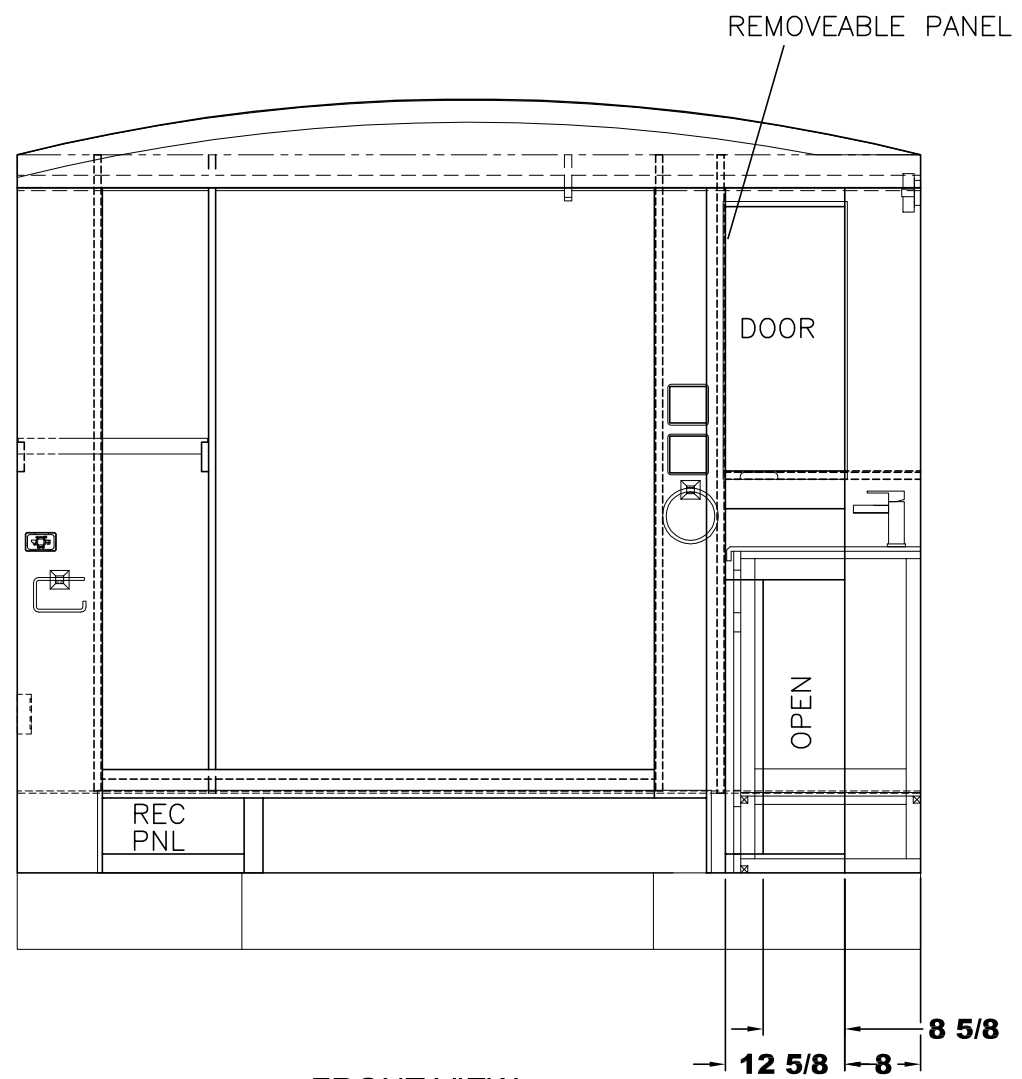
